From the desk of OAAS Treasurer, Kerry McDonald

Is your Fair exempt from HST registration?

Different rules apply to Not-for-Profits vs. Registered Charities when it comes to HST.

If your Fair is already HST-registered but doesn't "need to be" there is a process to de-register. It involves proving to Revenue Canada that you meet the necessary exemptions listed below.

Registered Charity Fairs: A Registered Charity is exempt from registering for HST **IF** their annual gross income is less than \$250,000 *OR* their gross taxable income is less than \$50,000. If you can say yes to *either* of these then you do not need to be HST-registered.

IF your Charity is NOT HST-registered then you qualify to submit an application for a Public Service Bodies' Rebate to receive a partial refund of the HST that your Fair has paid to others each year. If your Fair has never submitted a Public Service Bodies' Rebate application you can submit one application for each of the past four (4) years.

Not-for-Profit Fairs:

A Not-for-Profit Fair (all Fairs that are NOT Charities) is exempt from registering for HST **IF** their annual taxable income is less than \$50,000.

If your Charity is NOT HST-registered and receives at least 40% of their funding from a government agency then you qualify to submit an application for a Public Service Bodies' Rebate to receive a partial refund of the HST that your Fair has paid to others each year. If your Fair qualifies and has never submitted a Public Service Bodies' Rebate application you can submit one application for each of the past four (4) years.

MPP Pettapiece recognizes 100th anniversary of Listowel Armouries

(Queen's Park) – MPP Randy Pettapiece delivered a member's statement in the Ontario legislature celebrating the 100th anniversary of the Listowel Armouries. He spoke about Saturday's commemoration ceremony and the history of this important local landmark. The following is the text of his remarks: "I am pleased to recognize the 100th anniversary of the Listowel Armouries. "On Saturday, I had the privilege of attending the commemoration ceremony to mark this milestone. The celebration highlighted the Armouries building and honoured those who trained there, those who served our country overseas, and those currently serving. "The event featured an advance demonstration by the Guelph Regiment, an afternoon fly-over of two World War One vintage aircrafts, viewings of large war memorabilia collections, and a moving piece by Cambridge artist Dave Sopha which features the portraits of our fallen Canadian soldiers from the Afghanistan War. "The Listowel Armouries was originally built in 1914, and housed the 100th Battery of the 21st Royal Canadian Artillery Regiment through both the first and second World Wars. The Listowel Agricultural Society acquired the building in 1970, preserving the traditional armoury style.

"Today, the building is known as the Listowel Agricultural Hall, and is busy year-round with fund-raising events, celebrations and the annual Listowel Fair. I would like to take this opportunity to thank everyone who contributed to Saturday's celebration. Thank you to Elizabeth Johnston, the fair organizer, and the entire Listowel Agricultural Society, all of whom have worked tirelessly putting this event together. "Thank you to the councils and staff of North Perth and Perth County, which have supported this project since the beginning. "Thank you to the many donors and sponsors who came together to offer their support. "And to the many volunteers, participants and attendees – thank you for celebrating this historic landmark."

Copyright Infringement: With the increase availability of material and personal works now readily available on the internet, copyright infringement and legal cases surrounding them are on the rise. Before your society thinks about using, copying or displaying someone else's work, make sure your society is protected and has the legal rights/permission to use the work or material. Fulltime organizations now scour the internet daily looking for their or their client's work being used without permission in newspapers, fair books, and websites. If organizations or people are found to be using copyrighted works without permission, legal action is possible against the organization. Copyrighted work protects the owner or the organization that represents the owners work to solely reproduce, distribute, perform and/or display it.

How do I get permission to use someone else's work?

If your use isn't permitted by a license, or one of the exceptions in the Copyright Act, you will need to ask for permission. The permission must come from the copyright owner or the organization that represents the owner.

Always seek written legal permission before using anyone's personal works, and state what it will be used for. Just because it is on the internet, does not mean it is readily available to be used without permission. Even works that do not say copyrighted are usually still protected. If you are still unsure, your organization should contact a local legal representative.

Ambassador Experience Day in District 13 ~ On Saturday July 12, District 13 hosted an

Ambassador Experience Day in Glencoe, Ontario for all of their Ambassadors and for Ambassador committee members. In addition, the Ambassadors and committee folks from District 9 were also invited to attend. Ambassadors attended, representing Glencoe, Wallacetown, Brooke-Alvinston, Plympton-Wyoming, Forest, Thorndale, Ilderton, Petrolia, Dorchester, Leamington, Ridgetown, a fun and interesting program was put together by District 13 Ambassador Alumni.

The feedback on this portion from both the ambassadors and the interviewers was incredibly positive. The ambassadors felt it was very beneficial to experience all of these different types of interview situations and the interviewers were very impressed with the quality of the participants.

The ambassadors also took part in an activity where they paired up and came up with an out line of a plan for a new event for their fair. Some really great ideas came out of this!

The committee member portion of the day took the format of a roundtable discussion of the issues facing Ambassador programs across our area and the province.

We had participants taking part from Brigden, Brooke-Alvinston, Glencoe, Ridgetown, Ilderton, Dorchester, Forest, Western Fair District, Comber and Ridgetown. Issues like getting participants, promotion of the program, types of and remuneration for judges, having successful committees, and clothing issues at convention and CNE were just some of the topics that were discussed. The committee people that took part were very pleased with the opportunity to exchange information, and talk about not only problems, but to talk about things that work really well as well.

Turning 100 is a preffy big deal.


We know that marking a full century of creating strong youth leaders, building communities, and sharing the tradition of "Learn To Do By Doing" is truly something to be proud of.

And as you develop your local plans for anniversary celebrations across the province, we look forward to joining in. Let's all make 2015 a year to remember — for the next century, and beyond.


